Special and/or sensible personal data that we process

Our website and/or service does not have the intention to collect data of website visitors younger than 16 years. Unless they have permission from their parents or guardian. We can, however, not check if a website visitor is below 16 years. For what purpose and on what basis do we process personal data

Invest Mobile BVBA processes your personal data for the following purposes:

- To call or email you in case that's necessary to provide our services
- To inform you about any changes from our services and products

Automated decision-making

Invest Mobile BVBA does not make decisions based on automated processes about affairs that could have (significant) effects for people. It is about decisions that are made by computer programs or systems, without a person (i.e an employee of Invest Mobile BVBA) between it.

How long do we keep the personal data

Invest Mobile BVBA does not keep your personal data for longer than strictly necessary to achieve the goals for which the data was collected.

Personal data sharing with third parties

Invest Mobile BVBA will not sell your data with third parties and will exclusively share your data if necessary in order to execute our agreement or to comply a legal obligation. In order to guarantee a same level of security and confidentiality, we conclude a processing agreement with companies that process your data in our commision. Invest Mobile BVBA will always be responsible for these processes.

Cookies, or similar techniques that we use

Invest Mobile BVBA only uses technic and functional cookies. A cookie is a small text file that will be saved on your computer, tablet or smartphone on the first visit of this website. These cookies are necessary in order to create a website that works both technically and conveniently. These cookies make sure the website works as it should work and remember your preferences. We can also optimize our website by using these cookies.

If you do not want to make use of cookies, you can sign yourself off by setting your browser up that it does not save cookies anymore. Besides, you can delete all the previously saved information by your browser.

Google Analytics

Via our website, a cookie will be placed by the American company Google, which is part of the "Analytics"-service. We use this service to keep us up to date and to receive reports on how visitors use the website. Google can give this information to third parties if they are legally obligated, or if third parties process information in name of Google. We do not have any influence on this. We did not permit Google to use the gained analytics information to use it for other Google services.

The information collected by Google will be anonymized as much as possible. Your IP-address will emphatically not be given.

Adjusting, deleting or looking through data

You have the right to look through your personal data, you are also allowed to correct the data and/or delete it. Besides that you also have the right to recall permission of your personal data or to fill a objection of the process of your own personal data by Invest Mobile BVBA. You also have the right on data portability. This means that you can send us a request to send the personal data we collected in a computer file to you or another organisation.
